

Community Plan Update

- Progress during 2018 General Use Permit (GUP) process
- February 11, 2020, Board of Supervisors' direction
 - SCP Update
 - Municipal Services Study
 - Graduate Student Affordability Study
 - Childcare Study
- To be completed by end of 2022



Affordability Study Background and Purpose Background

2018 Affordable Housing Nexus Study

- Addressed housing affordability for Stanford workers (faculty, staff, post docs, contract)
- Supported adoption of inclusionary and affordable housing mitigation fee ordinances
- Graduate students not studied or addressed by adopted ordinances


2020 County Board of Supervisors' Direction: consider available additional measures, if any, that might be taken to ensure the affordability of housing to graduate students

Purpose

Determine if there is evidence of housing affordability challenges for a share of Stanford graduate students.

Graduate Student Population

~ 9,300 Total Graduate Students (for 2021-22)



How Graduate Students Finance Tuition and Living Expenses

Percent Accessing Funding Source	<u>PhD</u>	<u>Masters</u>	Professional
Assistantship or Fellowship			
 as only funding source 	55%	12%	3%
 as one of multiple funding sources 	<u>43%</u>	<u>48%</u>	<u>64%</u>

Family/partner support or savings	38%	77%	84%
Student Loan Debt	4%	32%	67%
Outside Employment	7%	12%	10%
Another Source	3%	2%	5%
Credit Card / Other Debt	2%	2%	2%

Note: figures add to more than 100% because many students use multiple funding sources.

Stanford Graduate Student Housing

~75% live in Stanford-provided housing (on and off-campus)

Existing units approximately meet existing demand

Rents for 85% of Stanford housing spaces affordable at Low or Moderate income

- 29% at Low Income
- 56% at Moderate Income
- 15% are above the moderate level (over 120% AMI)

Affordability Study Approach

To determine if a share of graduate students experience affordability challenges:

Use data from 2021 survey by Public Consulting Group with assistance of Graduate Student Council and other student organizations

Screen for affordability challenges using qualitative survey questions

- Evaluate resources (stipends, grants, loans, help from parents) vs. estimated living expenses
- Consider "gap funding" (maximize loans, Stanford's targeted assistance programs)
- Evaluate ability to meet living expenses, inclusive of housing and all other expenses

Affordability Study Findings

16%	 Say they experience frequent financial challenges and/or food insecurity
10%	 Have an estimated gap in resources for housing and other living expenses
5%	 Have an estimated gap in resources after potential "gap funding"

Affordability Challenges Most Prevalent Among:

International Students

- 12% with gap in resources
- Visa restrictions that prevent a spouse from working
- Student loan access may be more limited

Students with Children

- 14% with gap in resources
- Added childcare, healthcare, housing expenses
- Financial aid / loan formulas oriented to single students
- Considers Stanford's Graduate Family Grant

Recommendations

- **1. Expand targeted assistance** to graduate students facing financial challenges.
- 2. Create University-sponsored student loan program to expand access to loans for international students, couples, and families.
- 3. Link expansion of campus to expansion of housing specific to graduate students.
- 4. Evaluate expansion of Inclusionary Housing Ordinance to include graduate student housing.
